1. Offers not conforming to the specification given in the schedule and without the relevant documents will be rejected.
2. The rates should be quoted in the tender schedule itself.
3. **The tender should sign in all the sheets attached with the tender and tender schedule including special conditions**
4. Tenders not satisfying the above special conditions are liable to be rejected without any further communication.
5. The work should be completed within 60 days from the date of starting of work.
6. The undersigned reserves the right to reject any or all tenders without assigning any reasons.
7. Penalty @ 1% per week will be imposed for any delay in completing works after 80 days of work order subject to a maximum of 10%
8. All materials like cement, sand, steel, water etc. will be provided by Nirmithi Kendra as per site requirement in time.
9. Shuttering materials should be provided by the labour/mason
10. Work should be carried out with at most care and quality as directed by the site in charge.
11. Measurement will be taken only for shuttering area for lintels, beams and pillars and for slab, the top area will only be considered.
12. Nails, food etc. will not be provided by Nirmithi Kendra
13. Mechanical vibrators, mixer machines etc. Should be used at site by the labour/mason at his own cost.
14. Part payments against the progress of work can be released by Nirmithi Kendra depending on assessment of the progress of work.
15. The labour engaged by the contractor should have EPF, ESI registration
16. The safety for the labours engaged by the contractor will be sole responsibility of the contractor.
