7. Penalty @ 0.05% per day will be imposed for any delay in completing works after 180 days of work order subject to a maximum of 10%
8. All materials like cement, sand, steel, water etc. will be provided by Nirmithi Kendra as per site requirement in time.
9. Scaffolding materials should be provided by the labour/mason
10. Work should be carried out with at most care and quality as directed by the site in charge.
11. Vibrator and mixing machine should be used for concreting works.
12. Nails, food etc. will not be provided by Nirmithi Kendra
13. Part payments against the progress of work will be released by Nirmithi Kendra on monthly basis depending on assessment of the progress of work.
14. All statutory payments towards the welfare and safety of labours engaged will be the sole responsibility of the contractor/mason including safety of labours
